Sir,

Research and innovation are utmost important in the field of AYUSH stream which involve arduous scientific/ clinical effort in the search of veracity, creation of new knowledge. Responsible conduct of research and safeguarding ethics and academic integrity in scientific research of AYUSH Stream are also extremely crucial.

- 2. Credibility of research publications is extremely important. High quality publications in reputed journals help in achieving higher global ranks and overall improvement of quality of education. Publication in predatory /dubious/ sub-standard journals has become a serious concern and reflects adversely leading to increased incidence of compromised publication ethics and deteriorating academic integrity in all domain of research. Unethical / deceptive practice in publishing are leading to an increased number of dubious/ predatory journals worldwide and also observed that in India the percentage of research articles published in predatory journals is high.
- 3. In view of the above, in order to avoiding plagiarism in academic writing and discourage the research Publication in the predatory /dubious/ sub-standard journals, CCIM and CCH are requested to ensure that publication of articles relating to AYUSH systems shall be only in journals indexed in 'UGC- CARE List" which is used for all academic purposes.
