

Sir/Madam,

In continuation to the Department's letter of even No. dated 16.05.2014 wherein a Letter of Intent was issued to the college with respect to the proposal submitted to the Central Government as cited above, I am directed to say that after careful consideration of recommendations of the CCIM in terms of the provisions of the IMCC Act, 1970 and relevant regulations made thereunder and approved norms for academic session 2014-15 vide Department's letter No.R.11011/10/2013-EP (IM-1) dated 17.06.2014 (available on Department's website <www.indianmedicine.nic.in>); permission of the Central Government is hereby granted to the BBSPM's Dhanwantari Ayurved Medical College & Hospital, Udgir, Dist. Latur- 413517, Maharashtra for increase the admission capacity from 50 to 60 seats (10 additional seats) in existing UG (BAMS) course, from the academic session 2014-15 to the academic session 2018-19 under section 13A of the IMCC Act, 1970. Therefore, the college may take admissions at increased UG seats from the academic session 2014-15 to 2018-19 subject to the fulfilment of the requirements as indicated ahead in para 4.

2. This permission to increase in admission capacity from 50 to 60 seats for the first admitted batch of 2014-15 session, will be valid till such time as the first batch of students admitted against this course appear for the first final examination of the said course and at that time, the College authorities may take up the matter for recognition of the qualifications under Section 14(2) of the IMCC Act, 1970.

3. The college administration will ensure that sufficient qualified teachers, as prescribed in the relevant CCIM Regulations, are in position before the admission of the students in the above-mentioned course is made, under intimation to the Central Government and CCIM.
4. Further, to obtain the permission for academic session 2019-20 onwards and to take admissions in the above said increased intake capacity in existing UG course, the college shall maintain all the Requirements of infrastructure and teaching & training facilities as specified in the Indian Medicine Central Council (Minimum Standard Requirements of Ayurveda Colleges and attached Hospitals) Regulations, 2012 read with amendment Regulations, 2013, provisions of the IMCC Act, 1970 and relevant Regulations made thereunder in toto during the period of permission (i.e. up to 2018-19) as intimated by Department vide letter no.R.17011/161/2014-EP (IM-1) dated 31.07.2014 which may be verified either by the Central Government or by the Central Council of Indian Medicine on receipt of any complaint. Further, as per the provisions of Sub-Regulation (2) of Regulation 3 of the MSR Regulations, 2012, the Central Council shall visit the college *suo moto* three months before the expiry of permission to verify the requisite infrastructure and facilities required under above mentioned Regulations by means of an inspection and shall submit a report to the Department of AYUSH for considering the permission matter from the academic session 2019-20.

With reference to the subject mentioned above, I am directed to inform you that in pursuance of the provision of National commission for Indian System of Medicine Act, 2020, the Indian Medicine Central Council Act,1970 (48 of 1970) has been repealed with effect from the 11th day of June, 2021. With effect from the said date, the Central Council of Indian Medicine constituted under sub-division (1) of section 3 of the Indian Medicine Central Council Act, 1970 (48 of 1970) shall stand dissolved. Now, in exercise of the powers conferred by sub-section (3) of the section 1 of the said Act, the Central Government hereby notifies that all the provisions of the National Commission for Indian System of Medicine Act, 2020 has been come into force with effect from the 11th day of June, 2021 and as per regulation 59 (2) of The National Commission for Indian System of Medicine ACT, 2020, Medical standards, requirements and other provisions of the Indian Medicine Central Council Act, 1970 and the rules and regulations made there under shall continue to be in force and operate till new standards or requirements are specified under this Act or the rules and regulations made there under.

Further, the provision of concerned regulations which are inconsistent with the provision of NCISM Act, 2020 shall not be applicable.

1. Further, to assess the available facilities of teaching, non-teaching, Hospital staff, practical training and other infrastructure facilities at your college namely to **Bal Bhagwan Shikshan Prasarak Mandal's Dhanwantari Ayurved Medical College & Hospital, Degloor Road, Udgir-413517, Distt. Latur, Maharashtra, (Inst. Id-AYU0189)** inspection of your College was conducted on **06.09.2022 & 07.09.2022 on virtual mode** as a part of annual visitation by the visitation team of Medical Assessment and rating Board, NCISM to process **the Conditional permission for intake capacity with 60 seats in UG (BAMS) course for the academic session 2022-23.**
2. Further, the visitation report and all other related documents were assessed in terms of the enforced regulations namely, the "Indian Medicine Central Council (Requirements of Minimum Standard for under-graduate Ayurveda Colleges and attached Hospitals) Regulations, 2016", provisions under the NCISM Act, 2020 and relevant Regulations there under, and on the basis of Relaxation policy issued by the NCISM dated 16.03.2022.
3. As per the direction of President, Medical Assessment and Rating Board for Indian System of Medicine (NCISM), the assessment report was placed in the **Seventeenth Board meeting** of Medical Assessment and Rating Board for Indian System of Medicine (NCISM) held on **11.11.2022**. On careful examination of the assessment report it is found that **your college is fulfilling the notified & approved criteria. Hence Board decided to issue the Conditional permission for intake capacity with 60 seats in UG (BAMS) course for the academic session 2022-23.**
4. Therefore, it has been decided by the President, Medical Assessment and Rating Board for Indian System of Medicine to **grant conditional permission to Bal Bhagwan Shikshan Prasarak Mandal's Dhanwantari Ayurved Medical College & Hospital, Degloor Road, Udgir-413517, Distt. Latur, Maharashtra, (Inst. Id-AYU0189) for intake capacity with 60 seats in UG (BAMS) course for the academic session 2022-23 under section 28 of NCISM Act, 2020** subject to the condition that college is fulfilling the following requirements:-
 - I. The college shall submit an undertaking in the form of affidavit duly notarized within one month explaining the details of providing EPF and ESI facilities to the teaching, non-teaching staff of the Colleges/Hospitals and regularly paying the same as per the provisions of Employees' Provident Funds and Miscellaneous Provisions Act, 1952 & ESI Act, 1948 and relevant Rules and Regulations.

- II. It is further informed that minimum 15% of undergraduate seats of the permitted intake capacity with 60 seats shall be treated as all India quota. The counselling for seats under all India quota shall be conducted by respective counselling authority as designated by Central Government for A.Y. 2022-23 and counselling for the remaining 85% seats or as the case may be, shall be conducted by the concerned Counselling Authority of that State/UT. **The permission of the college stands withdrawn if the college fails to comply with the aforesaid direction of the Central Government/NCISM for all India quota or the students admitted thereunder.**
- III. It is also informed that the determination of fee and all other charges in respect of 50% of seats in Private Medical Institutions and Deemed to be Universities should be as per the guidelines issued by NCISM vide ref.no. BUSS/Fee/ASU/2022-23 dated 16.09.2022. Fees of the remaining 50% of seats are to be fixed as per the guidelines of Fee Fixation/Regulatory Committee (FRC) of the respective State/UT/Deemed to be University.
5. Admissions made in violation of the above conditions will be treated as invalid and action will be initiated under NCISM Act & Regulations thereunder.
6. Discrepancies, if any, may be immediately brought to the notice of Medical Assessment and Rating Board for Indian System of Medicine, NCISM.
7. **The following requirements should be fulfilled by the college by 31st December, 2022 and send a compliance report to get permission for the session 2023-24:-**
- all the requirements of Minimum Standard of infrastructure and teaching & training facilities as specified in Regulation 3 of the "Indian Medicine Central Council (Requirements of Minimum Standard for under-graduate Ayurveda Colleges and attached Hospitals) Regulations, 2016;
 - all the requirements of the Indian Medicine Central Council (Minimum Standards of Education in Indian Medicine) Amendment Regulations, 2016 (for Ayurveda);
 - all the requirements under the provisions of the NCISM Act, 2020 and relevant Regulations made thereunder should be fulfilled in toto; and
8. The fulfillment of the conditions given above may be made within the time period specified and compliance report should be submitted by the college to President, Medical Assessment and Rating Board for Indian System of Medicine. The Medical Assessment and Rating Board for Indian System of Medicine will verify that the conditions have been fulfilled for considering the permission from the academic session 2023-24.
