- (01) To avail benefits such as Fees relaxation under various schemes, candidates must submit an income certificate Issued by Tahsil for the year 2025-26 otherwise, they will not be eligible for any relaxation in the fees.
- (02) To claim benefits under the scheme for SEBC and EWS, the candidate is required to submit copy of Income Certificate (for the year 2025-26) Ration Card, Domicile, and Aadhar Card.
- (03) Other fees such as MUHS Enrolment, Eligibility, Development, and Ashvamedha & Sports fees as specified in the MUHS circular must be borne by the candidate to secure admission.
- (04) The above stated fees will be revised after confirmation from Fees Regulating Authority for the academic year 2025-26, which is still pending. Therefore, the fees will differ as per the new directions and will be applicable to all without exception. Complete Fees is to be paid during admission of every academic/calendar/financial year as per the policy. If fees is not paid within stipulated time then action will be or can be initiated as per the rules.
- (05) For NRI Fees:- As per FRA decision dated 02/11/2023 fees up to 5 Times of the general seats fees will be charged for the students admitted in NRI / against NRI Seats.
- (06) If scholarship form is denied because of any technical reason including delay in submission or daily attendance in college or incomplete documents then it will be the responsibility of the student & his/he parent.
