**Sub: Grant of conditional permission to Dhanwantri Ayurved Medical College, Infront of Kala Mandir, Nanded Road, Udgir, Distt. Latur – 413517, Maharashtra with 60 seats in UG (BAMS) course under Section 13C/13A of the IMCC Act, 1970 for the academic session 2018-19 – reg.**

Sir,

I am directed to refer to the Ministry's order No. R-17011/161/2014-EP (IM-1) dated 31.07.2014 granting permission for a period of not exceeding five years from the academic session 2014-15 to the academic session 2018-19 with 50 seats in UG (BAMS) course and to Ministry order dated 16.10.2014 to increase in admission capacity from 50 to 60 seats (10 additional seats) in existing UG (BAMS) Course from the academic session 2014-15 to the 2018-19.

2. The aforesaid college was inspected by the surprise visitation team in accordance with Rule 3 (2) of the Indian Medicine Central Council (Requirement of Minimum Standard for under-graduate Ayurveda colleges and attached Hospitals) Regulations, 2016 on 12.07.2018 to ascertain the position/status of the ASU colleges and submitted the inspection report to the Central Government.

3. On examining the said report in terms of the Indian Medicine Central Council (Requirements of Minimum Standard for under-graduate Ayurveda Colleges and attached Hospitals) Regulations, 2016, provisions under the IMCC Act, 1970, other relevant regulations made thereunder, several fundamental deficiencies were observed which are adversely affecting the purpose of quality medical education. Therefore, the Ministry vide letter dated 17.08.2018 directed the college to rectify the deficiencies within a period of 20 days (i.e., 06<sup>th</sup> September

2018) and submit the compliance report otherwise it was further informed that the permission granted for a period of five years shall deemed to be withdrawn.

4. In response to the Ministry's letter dated 17.08.2018, the Principal, Dhanwantri Ayurved Medical College, Infront of Kala Mandir, Nanded Road, Udgir, Distt. Latur – 413 517 has submitted a compliance report with reference no. DAMRD/09/2018 dated 04.09.2018 to this Ministry which was received on 06.09.2018. However, on analysis of the submitted compliance report it was found that, the college was not fulfilling all the requirements especially regarding required number of higher faculty, teachers in department of Swasthavritta & Yoga, Shalya Tantra & Kayachikitsa, functional X-Ray, USG and ECG, area of Demonstration room, Equipment's and Instruments in the Physiology and Ras Shastra & Bhaishajya Kalpana Laboratory.

5. In view of the above deficiencies, under provisions of the first proviso to sub-section (5) of Section 13A of the IMCC Act, 1970, an opportunity of hearing was granted to the college on 08.10.2018, to present the case. The college through its representatives Dr. Dattatreya V Patil, Principal and Dr. Rajendra Dhate, Professor, Dhanwantri Ayurved Medical College, Infront of Kala Mandir, Nanded Road, Udgir, Distt. Latur – 413 517, Maharashtra appeared before the Hearing Committee on 08.10.2018. Further, in view of the observation of the Hearing Committee, it was observed that college could not produce sufficient documents/evidences to substantiate their claim of having required number of Higher faculties, teachers in each Dept., functional X-Ray, ECG, USG and Instruments & Equipment's in Physiology Laboratory as per sub regulation 2 of regulation 3 of RMS, 2016, which are essential prerequisite to grant permission for period not exceeding five years in terms of the provisions of the IMCC Act, 1970 and the notified RMS, 2016 (Requirements of Minimum Standard for under-graduate Ayurveda Colleges and attached Hospitals) Regulations, 2016 and other relevant regulations. However, on examining the Visitors report and observation of hearing Committee in terms of sub-regulation 3 of Regulations 3, it is observed that the college is fulfilling all the requirements for granting conditional permission for the academic year 2018-19 except functional X-Ray, ECG and USG.

6. Therefore, it has been decided by the Central Government to **withdraw the earlier permission granted** for a period not exceeding five years from the academic session 2014-15 to the academic session 2018-19 with 50 seats in BAMS (UG) course vide letter F.No. R.17011/161/2014-EP (IM-1) dated 31.07.2014 & F.No. R-13011/43/2013- EP (IM-1) dated 16.10.2014 to increase intake capacity from 50 to 60 seats in existing UG (BAMS) course and decided to convert it into ***conditional permission*** to take admissions for ***60 seats in UG (BAMS) course*** to **Dhanwantri Ayurved Medical College, Infront of Kala Mandir, Nanded Road, Udgir, Distt. Latur – 413517, Maharashtra** under Section 13C/13A of the IMCC Act, 1970 for the academic session 2018-19 only, subject to condition that the college shall fulfill the following requirements by 31<sup>st</sup> December, 2018:

- i. Functional X-Ray, ECG and USG facility in the hospital.

7. The College is also directed that the following requirements should be fulfilled by the college positively by the 31<sup>st</sup> December, 2018, which will be verified for granting permission from the academic session 2019-2020 onwards:

- (i) all the Requirements of Minimum Standard of infrastructure and teaching & training facilities as specified in Regulation 3 of the "Indian Medicine Central Council (Requirements of Minimum Standard for under-graduate Ayurveda Colleges and attached Hospitals) Regulations, 2016;
- (ii) all the requirements of the Indian Medicine Central Council (Minimum Standards of Education in Indian Medicine) Amendment Regulations, 2016 (for Ayurveda) and
- (iii) all the requirements under the provisions of the IMCC Act, 1970 and relevant Regulations made thereunder should be fulfilled *in toto*.

8. The fulfillment of the conditions attached to the permission given above may be made within the time period specified and compliance report should be submitted to the Ministry of AYUSH endorsing a copy to the CCIM also. The CCIM will verify that the conditions have been fulfilled by means of an inspection and submit a report in this matter to the Ministry of AYUSH for considering the permission matter from the academic session 2019-20.


